

TELESENSE PRIVACY POLICY

Effective Date: February 1, 2023

Decco U.S. Post-Harvest, Inc. (“Decco” or “we” or “our” or “us”) is committed to keeping any and all personal information collected of those individuals that visit the TeleSense website at <https://www.telesense.com>, web application at <https://telesense.app> and/or mobile applications (“Sites”) accurate, confidential, secure and private. Our Privacy Policy has been designed and created to ensure those affiliated with our TeleSense platform of our commitment and realization of our obligation not only to meet but to exceed most existing privacy standards.

This Privacy Policy describes how Decco treats information collected or provided in connection with an end user’s (“you” or “your” or “user”) use of the Sites. Please note that your use of the Sites constitutes your acceptance of this Privacy Policy as set forth below:

Collection of Information

The Sites collect various types of information, such as:

Use of Information Collected

Decco may collect and may make use of personal information to assist in the operation of the Sites and to ensure delivery of the services you need and request. Disclosure of Information Collected

A) Decco may disclose your personal information, without prior notice to you, if required to do so in accordance with applicable laws and/or in a good faith belief that such action is deemed necessary or is required in an effort to:

- Remain in conformance with any decrees, laws and/or statutes or in an effort to comply with any process which may be served upon Decco and/or our Sites;
- Maintain, safeguard and/or preserve all the rights and/or property of Decco; and
- Perform under demanding conditions in an effort to safeguard the personal safety of users of the Sites and/or the general public.

B) Decco uses contractors and third-party service providers to assist us in the operation of the Sites, including service providers who assist us with providing customer service and e-mail newsletter management. Such third-party contractors or service providers may obtain access to the information you provide and/or collected via Decco's TeleSense devices, including personally identifiable information.

C) Decco may provide advertisers and other third parties with aggregated, non-personally identifiable website information about our user base and its interests and usage patterns. This may include making available or publishing aggregated, anonymous data regarding activity on the Sites.

D) The TeleSense website may include advertising served by third parties, which may be targeted to you based on your website usage. Decco may also partner with third party advertising companies in order to serve online advertising regarding our products and services to you after you use our website. Children Under Age of 13

Decco does not knowingly collect personal identifiable information from children under the age of thirteen (13) without verifiable parental consent. If it is determined that such information has been inadvertently collected on anyone under the age of thirteen (13), we shall immediately take the necessary steps to ensure that such information is deleted from our system's database.

Anyone under the age of thirteen (13) must seek and obtain parent or guardian permission to use the Sites.

Unsubscribe or Opt-Out

All users and/or visitors to our Sites have the option to discontinue receiving communication from us and/or reserve the right to discontinue receiving communications by way of email or newsletters.
